## **Questions and Comments:**

Questions, comments, and input raised by the CAC members during the meeting are summarized below:

- Will the environmental document be available to the CAC before it goes public?
- Will all alternatives presented tonight be included in EIR study?
- Does the slide with the projected costs include teardown and construction?
- Last meeting we had talked about bike lanes, turning lanes and pedestrian sidewalks, has any of that changed?
- Will the bridge stay the same width?
- When will the PDT present the final design?
- Will the design be presented to the community before the recommendation is signed and is it prudent to show it to the public before hand?
- We need to stop talking about retrofit; CAC agrees bridge should be replaced with a new design.
- Boyle Heights gets treated like a second class citizen, lets expedite the replacement process and eliminate bureaucratic red tape
- We should not expedite the process until all environmental requirements are met
- Why did the replication of the old bridge did not make it for consideration in the environmental analysis?
- It's disappointing to know that bridge might not be replaced with a replica.
- There is nothing special about the Dual Tower Extrados Bridge that was presented tonight.
- We would like to see fewer pillars to have future access to river.
- We need to make sure we are going to be proud of this design for the future?
- The new design must be spectacular; with the use of lighting we can make the new bridge a symbol for Los Angeles.
- Will the lighting be solar?
- Will be good benefit for Downtown and Boyle Heights to bring new bridge design concept.
- Someone from the PDT should call the City to replace the lights that were damaged during the recent copper thefts.
